1. PURPOSE OF THE INFORMATION STATEMENT

The purpose of the information statement is to outline for the public the necessary information required to make their inputs into the public participation process for granting long term rights to use, control or manage the Municipal Capital Assets listed below by way of leases.

Land to be Leased**

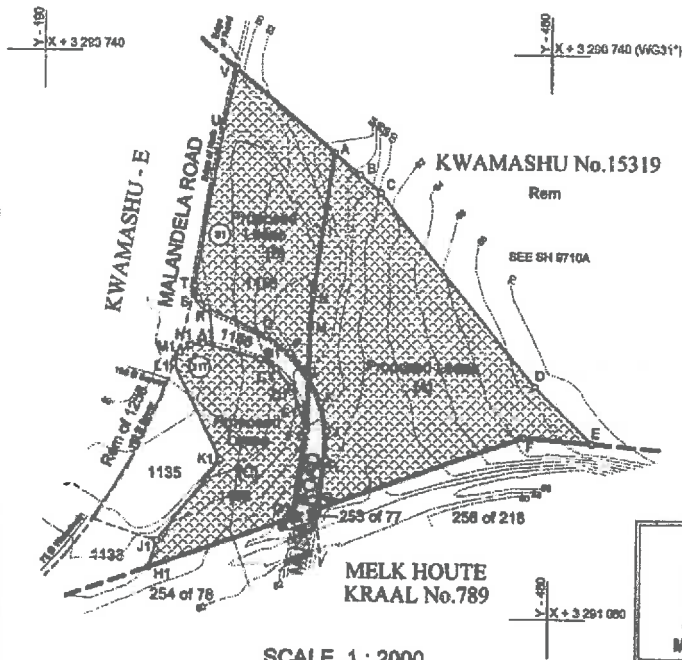
